ukraine to get 120 to 140 modern western tanks

KYIV UKRAINE said on Tuesday it was expecting up to 140 heavy tanks after its Western allies agreed to supply Kyiv with the powerful weapons following weeks of deliberations. "Ukraine's armed forces will receive between 120 and 140 modern Western tanks," Foreign Minister Dmytro Kuleba told reporters, describing the figure as the first wave of contributions.

US to talk weaponry after saying no to F-16 jets

WASHINGTON: United States President Joe Biden said on Tuesday that he will be discussing Ukraine's latest requests for advanced weaponry to defend against Russia with President Volodymyr Zelensky. "We're going to talk," Biden told reporters, speaking the morning after he answered with an emphatic "no" when asked at the White House whether he favoured sending F-16 fighter jets to Ukraine.

Couple in Iran given 10 years in jail for dancing

PARIS AN Iranian court has handed jail sentences of over 10 years each to a young couple who danced in front of one of Tehran's main landmarks in a video seen as a symbol of defiance against the regime, activists said on Tuesday. Astiyazh Haghghi and her fiancé Amir Mohammad Ahmadi, both in their early 20s, had been arrested in early November after a video went viral of them dancing romantically in front of the Azadi Tower in Tehran.

World economy outlook better but Britain is slipping; IMF

WASHINGTON THE outlook for the global economy is growing slightly brighter as China eases its zero-Covid policies and the world shows surprising resilience in the face of high inflation and Russia's ongoing war. The IMF now expects the world economy to grow 2.9% this year. That forecast is better than the 2.7% expansion for 2023 that the IMF predicted in October, though down from the estimated 3.4% growth in 2022.

However, the UK is a striking exception to the IMF's brighter outlook for 2023. It has forecast its economy will shrink 0.6% in 2023; in October, the IMF had expected growth of 0.3%. Higher interest rates and tighter government budgets are squeezing the economy. "These figures confirm we are not immune to the pressures hitting nearly all advanced economies," Chancellor of the Exchequer Jeremy Hunt said in response to the IMF forecast. "Short-term challenges should not obscure our long-term prospects—the UK outperformed many forecasts last year, and if we stick to our plan to halve inflation, the UK is still predicted to grow faster than Germany and Japan over the coming years."
